No More Excuses

The end is near! Or is it a new beginning? One way or the other there soon will be no excuse for all those Technician class amateurs not upgrading to General and Amateur Extra class [ARRL Letter, December 22, 2006]. You all know the excuse; "I can't learn that %\$#&* Morse code."

The code is dead; (or soon will be as far as license examinations are concerned). Long live the code; because it is far from dead as far as fun and utility is concerned. But that's a subject for another column.

So with no more excuses we hope to see all the club Technicians study up for the General and then the Extra exams. In the near future when the 5 wpm Morse code requirement is lifted you will be ready to take the exams to upgrade your licenses. The written exam question pool has been updated to include the spectrum changes, such as the expansion of the phone portion of the 40 and 80 meter bands that took effect on December 15, 2006. Be sure that you include these changes in your materials when you begin to study for your upgrade. See the ARRL Letter of December 15, 2006 for details of the changes. The entire question pool is available on the ARRL web site.

With the expectation that the code requirement will be lifted as soon next month, many of you may be inclined to take the written exam sooner rather than later. Assuming passage of the exam, you might apply for the upgrade when the rule actually takes effect. Yes this will work. The only drawback is that it will cost an additional \$14.00 to apply for the upgrade at a session other than the one where the exam was taken. Your best bet to save \$14.00 is to be a little patient, begin studying now, but wait until the code requirement is officially lifted. Then take the exam. The best guess is that by the time our March VE session rolls around the code requirement will be *history*.

N1ICN Named BARC Ham of the Year

Jim Clogher, N1ICN, was named BARC Ham of the Year for 2006 by membership vote. The presentation of a plaque was made at the Holiday Party on 13 December. Jim has been the BARC Treasurer for many years with no sign of malfeasance. Of course he has many other qualities to suggest that he was an outstanding choice. He has always been ready to help at public service events and supports the club in many internal functions. Hearty congratulations and thanks to Jim.

See How Easy It Is at the January Meeting

The EasySats are easy to use. Receiving FM signals from space is also simple. Miles Mann, WF1F is a first-hand authority who manages and schedules technology for the International Space Station (ISS). Miles will introduce us to the EasySats and the ham radio facilities on the Shuttle and on the ISS at the BARC meeting on 18 January.

Miles will tell us about Slow Scan Television (SSTV) in space and how to receive FM signals from space with simple, base-type equipment. He may also bring some gear to demonstrate his points. There are also some future space station ham projects he will let us in on.

Miles introduced the software concept and demonstrated the initial prototype SSTV setup with acceptance by ARISS/ARRL/AMSAT groups. He wrote the initial specifications for SpaceCam1 and manages developments and changes.

FCC To Eliminate Morse Code As Exam Requirement

The US will join the growing list of countries that no longer require Amateur Radio applicants to pass a Morse code test as the entry ticket to HF. The best estimate of when the Morse code requirement will go away officially is sometime in February (30 days after the R&O appears in the Federal Register).

"We... believe that the public interest is not served by requiring facility in Morse code when the trend in amateur communications is to use voice and digital technologies for exchanging messages," the FCC said in its R&O. "Rather, we believe that because the international requirement for telegraphy proficiency has been eliminated, we should treat Morse code telegraphy no differently from other Amateur Service communications techniques." The FCC says it deems the current regime of written examinations "sufficient to determine whether a person is qualified to be issued an Amateur Radio operator license."

The FCC also ordered that all Technician licensees present and future - whether or not they've passed a Morse code test, will get privileges on 80, 40, 15 and 10 meters identical to those of Novice licensees. "In eliminating this disparity between Technician and Technician Plus licenses, we are simplifying the Amateur Service licensing structure and promoting regulatory parity," the FCC said. The Commission further amended Part 97

"to authorize Amateur Extra class privileges to all individuals who have been issued a CEPT radio-amateur license by their country of citizenship, and who satisfy other requirements in the Commission's rules."

ARRL CEO David Sumner, K1ZZ, pledged that the League would maintain its traditional support of Morse code as an operating mode and would continue to offer Morse training materials as well as such incentives as bonus credit for CW contacts in ARRL-sponsored operating events. ARRL's Hiram Percy Maxim Memorial Station W1AW will keep its schedule of Morse code practice and bulletin transmissions. Sumner said other countries have successfully made the transition to a codeless testing regime, and he doesn't anticipate problems in the US.

The pending disappearance of the Morse code requirement seems to have rejuvenated the urge to upgrade. The distribution of General Class license training materials has skyrocketed in the week after the FCC announcement. The ARRL has posted information relevant to the FCC action in WT Docket 05-235, including an FAQ, on its Web site: www.arrl.org/fcc/morse/.

A DX bulletin replaces or is added to the regular bulletins between 0100 UTC Thursdays and 0100 UTC Fridays.

In a communications emergency, monitor W1AW for special bulletins as follows: Voice on the hour, Teleprinter at 15 minutes past the hour, and CW on the half-hour.

The W1AW Operating Schedule may also be found on page 102 in the November 2006 issue of *QST* or on the web at **www.arrl.org/w1aw.html**.

Daily Visitor Operating Hours: 1500 UTC to 1700 UTC 1800 UTC to 2045 UTC

FCC licensed amateurs may operate the station from 1500 UTC to 1700 UTC, and then from 1800 UTC to 2045 UTC, Monday through Friday. The station is closed 1700 to 1800 UTC. Be sure to bring your current FCC amateur license or a photocopy.




