# Message from the President - Linda M. Blair, NA11

#### For The Benefit Of All and All Of The Benefits

Well, we've made it through January and February, and now we've marched on into April. Time does not stand still and neither should we. I want to take a short peek at our future, but first some recent events need to be reviewed.

First, on behalf of the Club I want to extend our heartfelt appreciation to Casey4Hatchett, KB1REN, of the Brookline Police Department and her team for putting5together the C.E.R.T. presentation for our March General Meeting. Although the5attendance was small and the presentation brief, it was of the highest quality.6

Next I want to thank those who responded regarding some of the issues I raised in my March President's Letter. To those who paid their dues, thanks and welcome to another great year of membership in the **Boston Amateur Radio Club**. The same welcome is extended to those of you who have just joined us. May your experiences with the Club be fruitful and joyful. If it is not, tell us so we can try to do something to make things better for you.

In the matter of the Yahoo Group, we've recently had a flurry of activity. Many thanks to Mike Simonds, NZ5H, and Joe Flaherty, W1JJF, for getting the action started. Now the goal is to keep that action going because it looks like the Group is here to stay.

In the March issue of SPARC you saw the minutes of the 1 March Executive Committee meeting. Some questions have been raised about two of the actions of this Board and I would like to take a moment to explain why these actions were taken. The first I'll address is the issue of the Post Office Box. We had a request that a former member of many years ago, who is a resident and citizen of another country, be allowed to use the Club's P.O. Box address so as to have an address in this country for the F.C.C. regarding his license renewal. Indeed, I even retrieved one piece of mail for him from the P.O. Box. I do not know him. In fact, I never heard of him until this issue came up. I had no address to forward the mail to him or the means to forward it even if I had an address. I finally turned the piece of mail over to another member who had known the person.

But I am not the Post Office, nor is any other member. No one of us should be put in such a position, especially for a **FORMER** member who has not seen fit to keep his dues paid. Therefore, the Executive Board adopted the policy that the P.O. Box be used for Club business and Club business **ONLY**.

The second matter is that of the membership roster. Times have changed since the Club started. The methods of record keeping from previous eras are no longer effective. Ways of doing things are available now that did not exist then. Under the old method necessary information provided by the roster simply was not getting to those who needed it when they needed it. The answer is centralization of the roster. By putting the roster in a password protected centralized online location it can be accessed any time by anyone who has the authorized password. This is the way of today and that is why the Executive Board took this particular action. Note that this action does not affect the historical database which has been kept since the Club's inception by Bob Salow. Bob will continue to keep the historical database.

Finally, I want to discuss the issue of dues, when they are due and when one's membership status is changed if dues are not paid. Our fiscal year is the calendar year (By-Laws line 289). If a member pays dues by the last day of the third month of the calendar year, that member is said to be "in good standing." This is shown in the By-Laws:

#### 272 Member in Good Standing

- 273 A Member shall be considered to be in good standing if their dues are
- 274 current or in arrears by not more than three calendar months after the start
- 275 of the fiscal year.

From line 273 the term "in good standing" means that if one has not paid dues by the close of the three (3) calendar month period one is no longer a "member in good standing," but is still a "member", although not in good standing. In this case Club benefits for "members in good standing" may be denied to "members not in good standing." However, the membership itself is not jeopardized until the condition presents itself that after the close of the fiscal year the member has still not paid. If after that time the former member pays, the membership process begins anew with a new membership form appropriately completed and filed.

Of course we all know that something can happen to prevent a member from paying before the close of the third month. Also there is the case of the new member who joined after June 30 and pays the half-year rate. To accommodate these members let's take a look at another section of the By-Laws:

#### 258 Partial Year Membership Dues

- 259 Dues paid after June 30 shall be eligible for a rate of one half (½) of the
- 260 amount for the full year. A member paying such amount shall be eligible
- 261 for full membership benefits the same as if the full year rate were paid.

Please note lines 260 and 261. Since the fiscal year is the calendar year (By-Laws line 289) and if one pays after June 30, then that member is considered a member for the whole year beginning January 1, not for a whole year forward from the date the dues is paid. Therefore, membership is rightfully said to be retroactive to January 1 regardless of when the dues was paid as long as it was paid during the respective calendar year.

Keep in mind that Club elections are coming in June and if you are planning to run for office or want to become a member of the Executive Board, you must be a "member in good standing."

From the By-Laws:

#### 101 Eligibility for Office

102 All members in good standing shall be eligible to hold any of the offices,

One suggestion I would strongly advocate is that when you pay your dues, keep your receipt, be it a Paypal receipt, a canceled check, or a paper receipt, or whatever. And be sure that what the payment is for is marked on the receipt no matter what kind of receipt it is.

Okay, now the big question; why am I putting forth all of this concerning the dues? One answer is that recently some questions have been asked by members concerning these matters. I hope I have answered them sufficiently. Another answer has to do with the definition of "member in good standing." If you are no longer a "member in good standing" you can lose member benefits such as electronic delivery of the SPARC and membership in the Boston ARC Yahoo Group. To keep that from happening – well – you know what to do.

## **April Meeting - "Public Service"** -- Jim Bradley, KB1JKJ Note: Location change the April 19<sup>th</sup> BARC General meeting will be at Clay Center.

**Public Service Go-Kit;** With the winter almost over and our public service events starting next month, I decided to use the time to check out my equipment and put together a go bag for supporting public service events.

My kit starts with a Yaesu VX-7R, with the following accessories: an extra battery, mini speaker/ microphone, earpiece/microphone, microphone adapter, DC cable charger and Comet HT-224 antenna. I keep all these items in a canvas bag that I bought at a local hardware store; there were three bags in the set.

In one of the other canvas bags I keep a pad of paper, some post-it-notes



flashlight, a whistle, index cards, pens and pencils.

I carry these bags in a fanny pack, which I purchased from Campmor.com. The bag has two water bottle pockets on either side of the main compartment.

Also, in this pack I carry a personal first aid kit with sunscreen, a multipurpose tool, and a copy of the radio manual in a plastic bag, my BARC badge and some snacks for long days.

Just before the event I recharge the batteries, add two water bottles, route maps and event specific details which I keep in plastic document protector sheets.

Want to learn more about the ins and outs of Public Service events come to the April General meeting where we will be discussing Public Service events, operations, net control procedures and more.

To add further perspective to the ham public service concept, Bob Salow, WA1IDA, will describe the environment in which we provide support. This will cover such issues as the actual and perceived communications needs of the served agencies, interpersonal relations with the leadership, and geographic considerations. Also of significance is the recruiting and assignment of hams, selection of repeaters and the overall logistics of the ham operation.

# ARRL to Add Online QST For Members -- Bob Salow, WA1IDA

Beginning in June, in addition to the print copy of *QST*, all ARRL members will have access to an online, digital edition of *QST* at no extra cost. The magazine can be accessed from anywhere - on nearly any computer, laptop, mobile device, smartphone and tablet (including iPad, iPhone, and devices using the Android operating system).

Also in June, members will gain access to archived issues of *QST* from December 1915 to the present (previously, only issues through 2007 were available to members). A new archive will also be introduced for issues beginning January 2012, featuring enhanced functionality including full-text search.



#### Don't Buy Surplus Broadcast Towers – Yet -- Bob Salow, WA1IDA

The World Radio Conference (WRC-12) in Geneva has allocated a new ham band at 472-479 **KHz**. This secondary allocation does not take effect until 1 January 2013. Then the FCC would have to incorporate it into Part 97 before we could use it.

You could start looking for a World War 2 "Gibson Girl" emergency transmitter, however. This is (was) a yellow box, about a cubic foot, to be used at sea. It is shaped with concave sides and strapped between the knees. On top is a horizontal hand crank to generate power. Included is a reel of phosphor bronze wire for an antenna to be raised by balloon or kite.

It transmits on 500 KHz, formerly the international distress frequency, but now allocated to mobile maritime use. It should be able to be modified to work on the new MF ham band. In another year or so, you could then hook it up to that surplus broadcast band tower you have installed in your back yard.

#### ARRL Warns Members to Be Aware of Bogus Emails -- The ARRL Letter, March 15, 2012

Some ARRL members with **arrl.net** email accounts have recently received bogus emails, notifying them of a bill that supposedly needs to be paid. The email instructs the reader to click on a link to view the bill. Clicking on the link could release a virus that can infect your computer. Please be aware that these emails are *not* coming from the ARRL.

"If you receive an email like this and it looks like it originated from ARRL, please do not respond," explained ARRL IT Manager Michael Keane, K1MK. "The best thing you can do when receiving bogus emails is to simply add them to the spam list in your computer's email program and delete it. Please don't forward it to ARRL HQ - we will have already seen it and are already responding to it."

## BARC 70cm Repeater Off

Our 70cm repeater is off the air, until further notice. The 2M repeater on 145.230 remains operational. We are reviewing and revamping our total repeater support to the Greater Boston ham community.

#### Volunteer Examiners Needed - Hank, K1QK

BARC is in need of more Volunteer Examiners (VEs) for our exam sessions. In some cases we have only the required 3 VEs for our sessions. If any unforeseen situation arises and a VE is not able to make a session we would be forced to cancel the test.

There are some BARC members who are qualified VEs that have not been participating in the testing. We urge these VEs to attend our test sessions. If you can spare one night a month please come to a session.

We can surely use additional VEs. The test procedure for qualification is simple. Materials are available from the ARRL and the examination is an open book test. Hams with General and Amateur Extra class licenses are eligible to become VEs. If you would like to become a VE and help with the testing please contact Hank, K1QK or Jim, N1ICN.


## Quarterly Business Meetings -- Bob Salow, WA11DA


