





Minutes of the September 2015 Business Meeting – Joe Chapman, NV1W

The September 2015 Business Meeting was held at Brookline Police Headquarters on Thursday, September 3, 2015. Present were Joe Harris, N1QD (President), Mark Duff, KB1EKN (Vice President), Jim Clogher, N1ICN (Treasurer), Joe Chapman, NV1W (Secretary), Linda Blair, NA1I (Membership Services), Geri Duff, KB1ISQ (Public Information Officer), Blake Haskell, K1BTH, and Nathaniel Vishner, KB1QHX. The meeting was called to order by President Joe Harris at 7:33 p.m.

Officer Reports

President's Report: Joe, N1QD, noted that it's been a quiet summer and that he was glad to see many BARC members at the Boxboro convention.

There was no Vice President's report.

Treasurer's Report: Jim, N1ICN, reported that there is \$1000.10 in the repeater fund and \$2564.95 in the general account. Upcoming expenses include the Post Office box renewal in October. We will not have to do anything regarding our 501(c)(3) status with the IRS until 2018. We have finished moving our accounts to Eastern Bank and the Cambridge Trust account is now closed.

Secretary's Report: Joe, NV1W, noted that the SPARC is now being sent as a link to the copy on the BARC website rather than being sent as a large attachment to everyone on the mailing list. He has heard no comments, positive or negative, on the change.

Committee Reports

Repeater: Joe, N1QD (Repeater Trustee), reported that he asked both Joe Flaherty, W1JJF, net control for BARC's weekly net, and Greg Bennett, KC1CIC, representing the daily NTS traffic net, for comments on the VHF repeater and has heard no complaints. Problems with intermod and the repeater staying open have not been occurring, and N1QD noted that this might be due to one of the other organizations using the Federal Reserve having fixed their own equipment.

Mark, KB1EKN, noted that we still do have work to do on the VHF machine, in particular tuning the duplexer, reinstalling the polyphaser, replacing at least one cable (he noted that all the cables are at least fifteen years old at this point), and finishing cleaning out the equipment rack. The normal procedure for tuning a duplexer is to take it off site and then retune it after reinstalling it, and both N1QD and KB1EKN commented that a VHF duplexer is tricky to tune, particularly with the 600 kHz frequency pair spacing standard on two meters.

145.230 (-) CTCSS 88.5

On the UHF side, N1QD is planning a trip to the radio room on September 11. When we converted the UHF repeater to DMR, we found that it did not receive at all. There is a known bug reported against a similar Motorola repeater, so we may be able to solve the problem by reflashing the machine's firmware on-site. If this does not work, Ron Egalka, K1RE, a club member who operates a low-power DMR repeater from his condo on the Boston waterfront, has graciously offered to lend us his repeater so the BARC machine can be sent out for service. The repeater would continue to use Ron's call, frequency pair, and DMR color code.

John Garrett, WN9T, is asking the club to return the UHF antenna, which the club was led to believe he had donated. Blake, K1BTH, suggested that if and when we return the antenna we should include a letter stating that we believe BARC has no more of his property to help forestall any future misunderstandings. The group concurred. N1QD mentioned that another Boston area repeater uses an antenna that nulls out Pave Paws interference and is thus allowed to use higher power. This might be an option for the club, but such an antenna is expensive. He also said that we seem to have excellent coverage with only five watts.

Public service: Brett Smith, AB1RL, was not present, but he has sent email notices out for upcoming events.

Membership services: no report.

Old Business

Joe, N1QD, said he felt Field Day was a success. Mark, KB1EKN, reported that we spent approximately \$350, mostly on food and Field Day pins. He also suggested some changes to make: we need to do a better job protecting coaxial cables, as one of the 100 foot cables was damaged. We also can no longer tape cables to the floor, as it pulls off paint. We had one non–club member who showed up and wanted to operate, and we could have supervised him better. KB1EKN also recommended we buy a six meter filter and make an effort to have a two meter setup as well. A motion to make a donation of \$150 to the Bare Cove Fire Museum was voted and approved.

Bank transition: The move to Eastern Bank is considered a success, Linda, NA1I, observed that not only are we saving almost twenty dollars a month in fees, we're also earning interest.

Meetings: Linda, NA1I, described her schedule for arranging meeting space, and agreed to do this again for 2016. She will finalize the calendar with Brookline Police sometime in mid-November. She also noted that we will be using Eastern Bank's Jamaica Plain meeting facilities for the meetings we can't hold in Brookline Village, and that the location has parking and is accessible via public transportation.

Newsletter: Joe, NV1W, said he is willing to maintain a monthly schedule for the SPARC for at least the coming year, so we will not need to change the schedule at this time. Many commented that it would be nice to have more photos in the SPARC, and perhaps some followup articles on public service activities as well.

BARC breakfast: attendance was poor (one person) at the first breakfast in August. A discussion was had about whether it's good to schedule the breakfast on the day of the MIT flea, but no conclusion was reached. We decided to try again on Sunday, November 15.

New Business

The club will operate on SKYWARN Recognition Day on December 5 at the Great Blue Hill observatory as usual. Some changes in antenna configuration may be necessary because of the physical condition of the tower.

Holiday party: the group felt that having the party early in January was preferable to December because of parking issues at the Stockyard. A date of January 10 was proposed and Blake, K1BTH, will coordinate with the restaurant. SKYWARN Recognition Day will take the place of a December general meeting and the party will take the place of the January meeting.

145.230 (-) CTCSS 88.5

A motion to offer a 20% discount for renewals made before February 1 was voted and approved. We will be sending out letters with stamped return envelopes once again. There will be an envelope stuffing party at the December business meeting. K1BTH will supply envelopes and coordinate with Joe, NV1W, on mailing labels. Mark, KB1EKN, will obtain postage stamps.

A motion to spend up to \$100 to purchase a six meter filter was voted and approved. Joe, N1QD, will make the purchase.

Dave Capone, one of the speakers at the October general meeting, will be demonstrating cable connectors. KB1EKN did not think any of BARC's cables need new connectors, so we will not ask him to demonstrate on one of the club's cables. It was also observed that we should bring the club's PowerPole crimper and a supply of PowerPoles to a future meeting.

The meeting was adjourned at 9:14 p.m.

We give all exams (Technician, General, and Extra). Testing is by reservation only. Please bring the following with you:

- Your current license and a photocopy for the ARRL, if you are upgrading
- Any CSCEs you are claiming, and a photocopy of them
- Valid ID (picture ID preferred)
- A pen and a calculator (if you want to)
- \$15.00 (good for all the tests you take at that session, except for retests)

Note: Written tests can be taken sequentially at the same session for the same \$15 fee. The needed FCC forms will be provided.
