

#### Our President Speaks Ed Hennessy N1PBA

Happy New Year to all members of the Boston Amateur Radio Club. Let's hope 2000 is a good year for everyone.

Speaking of Y2K, thanks to everyone who was involved in preparations for emergency communications in the event of problems from the date rollover. It began to become evident by noontime on New Year's Eve that problems would be less likely than feared, as Australia, New Zealand, and Japan had few problems. But had something happened, hams in the area were ready. Special thanks goes to those hams who spent their New Year's Eve in EOCs or elsewhere besides home or with friends, ready to answer the call.

As a result of some of the Y2K preparation, BARC is close to arranging additional meeting space and a club shack. I won't say yet that this is a 'done deal,' but this is the closest we've been in a long time. It's promising, and more information will be provided when we know more.

The FCC has finalized the long-awaited restructuring of amateur licenses. We're going to have 3 classes of license (Tech, General, and Extra), with only one CW requirement of 5 WPM. Now's the time to consider upgrades–BARC's VE team expects some larger crowds between now and April 15, when the new structure takes effect. (Exam sessions are held on the second Monday of the month in Brookline. Details are elsewhere in the newsletter.) The new question pools have not been issued yet. If you have a license class that will cease to exist, you'll keep that license class and its privileges until you let your license lapse or you upgrade. Details will be forthcoming from the FCC and the ARRL.

# FCC License Restructuring Is Here.

On December 31st, the FCC finally announced their restructuring plan for ham radio licenses (I guess they had to do it by the end of the year and couldn't push it out



much past that day :-). The complete text can be found at:

The new plans go into effect on April 15th, 2000. Existing licenses will be unchanged; you can continue to operate and renew as before. There are no changes in the band plan or in operating privileges. After April 15th, the FCC will no longer issue Novice or Advanced class licenses. There will be new question pools for the three written exams (Tech, General, and Extra), which are currently being drawn up by the VECs, and a single 5WPM CW exam for General and Extra.

People who have CSCE's for having passed either the current General (3B) or Extra (4B) written exams after 4/17/1999 but haven't taken the 13 or 20 WPM CW exams will be able to apply for a General or Extra after the 15th (assuming they have their 5 WPM) by coming to a VE session and filling out a form 605.

What does this mean for ham radio? Everyone has their own opinion (ask three hams, you will get 5 opinions). We will have to see what the new question pools look like before we can draw judgement on them. As for the reduced CW requirement, Extras on 75M have proven that 20WPM CW doesn't keep idiots off HF. If you hear someone struggling along at 5WPM, jump in and make a QSO. At least they are trying, and remember that the best way for someone to increase their code speed is to get on the air and practice!

No matter what your feelings are to the FCC, to the ARRL, NCI, or other groups involved in the planning of the restructuring, don't take it out on new licensees or upgrades; they had nothing to do with it, and as long as they have a callsign from the FCC, they are hams just like the rest of us.

#### Hams Shine At Midnight Bob Salow, WA1IDA

If you can read this, you were not obliterated by the end of the world following the calendar rollover. Maybe there are some bargains to be had from those who overstocked on food, water, candles and generators.

BARC and BARC members were asked to coordinate communications support for several communities and agencies in the Greater Boston area as the calendar rolled over to the New Year. Many more hams were on standby, monitoring the repeaters in case crises developed, and specific assignments were needed. The earth turned smoothly into January, and no call outs were made.

ARES/RACES nets were established to run on the Waltham and Boston repeaters from early evening on 31 December through the early hours of 1 January. The nets were sources of current information, and handled traffic to and from the Massachusetts Emergency Management Agency (MEMA). If needed, recruiting of hams for disaster response could have been made.

At the Salvation Army headquarters in Boston, Mike, KB1CKF, Dick, KA1TUZ, Tony, N1OBL, and Ed, KA1KHK, managed the local Boston net on 2 meters and the nationwide Salvation Armv Team Emergency Radio Network (SATERN) net on HF.

Following preliminary Y2K tests last spring, the Veterans Administration Medical Centers (VAMC) in Boston requested a ham network be assembled to link their hospitals in Jamaica Plain, West Roxbury, Brockton and Northampton. At Jamaica Plain, Ed, N1VSJ, and Paul, N1LRT; at West Roxbury, Bob, N1ENS, and Richard, N1JDU; at Brockton, Carl, N1FYZ, Gil, WA1GDJ, and Joe, W1JOE; and at Northampton, John, WA1NTI; established stations to pass traffic among the senior hospital staff. The link between Northampton and Boston was through a 70-centimeter repeater on Mt. Wachusett.

The City of Everett was on the air with a temporary station set up by Rick, N1IWE. The city is about to purchase additional ham equipment to be installed at their emergency communications center.

At the Emergency Operating Center (EOC) in Cambridge, Arthur, N1NHZ, Ishmael, WA1VRB, Joe, N1RLO, Frank, N1DHW, Mike, N1IST and Ward, N1NQO, set up a solid station and provided a path to and from the outside world.

In the Newton EOC, Stu, K3KLQ, and Sam, N1QGF, overcame radio path problems to support the Newton Emergency Manager, Jay, WA1WIS. A permanent VHF/UHF ham antenna will be installed at the EOC shortly.

At MEMA headquarters (the "Bunker") in Framingham, Bob, WA1IDA, staffed the desk for the Voluntary Agencies Active in Disaster (VOAD). Supporting MEMA, VOAD coordinates activities of more than 35 non-profit agencies which respond to disasters – such as the Salvation Army, the American Red Cross and the Amateur Radio Emergency Service (ARES). Fortunately, the calendar rolled over quietly, and no activations were necessary.

In every one of the above assignments, the hams received high praise for their diligence and expert handling of support communications. In a few cases, rapid ham ingenuity was called upon to get a reliable station on the air, but it was done and done well. The served agencies became well aware of our professionalism.

#### The 2000 Boston Marathon

This notice is earlier than it has been in the past. Because of the millennial year (starting or ending the millennium – your choice), the Marathon field is being enlarged. It will be 50 percent larger than in recent years, but not as large as the 100th running in 1996. We have been asked to increase our ham radio operation along the course as well. There's no question that our performance has benefited the runner safety and strengthened the administration of the event.

Aside from the athletics and the competition, the Boston Athletic Association (BAA) has created one of the safest and user-friendly events of its kind in the world. It takes months of planning and over 7000 volunteers to make it so each year. More than 200 hams contribute time and skills toward a small, but vital, part of this classic event.

The Boston Amateur Radio Club has been asked to coordinate hams for emergency communications along the 26-mile course on Monday, 17 April 2000. In recent years about 130 hams from all over New England (and beyond) have turned out, but for 2000 we have even greater responsibilities to support safety and comfort for the runners and spectators. The registration papers were mailed 6 January. If you have not received them by the time you are reading this, contact Bob Salow, WA1IDA at once (see below).

The BAA has asked for each ham serving at the Marathon to have at least minimum experience in ham radio public service or emergency communications. This experience can be gained by participating in a public service event before the Marathon on 17 April 2000. The Marathon is an exciting and intense day, so duty at other events can serve as a lower key introduction. Because of an accumulation of changes in the past few years, all ham volunteers will be asked to attend one of the briefings we will hold from mid March through early April.

Whether you have volunteered before or you're new and haven't done it before, your help is needed for the 2000 Boston Marathon course. You will have a great time. Get the registration form back to the BAA promptly.


Commercial advertising in the newsletter provides important services to our members. Besides bringing income to defray the newsletter production costs, you can learn about and patronize those who support us.
