In either case, **make your check out to BARC** and give it and the ARRL membership form to the BARC Treasurer. He will handle the rest, and you will get all the benefits.

## Badge, Anyone?

As all members should know, BARC provides a call sign identification badge for all licensed members at no charge. Upon joining the club the badges are eagerly awaited. OK, so why are badges lying around with no ham to pin them on? The answer is simple, but the reasons may not be.

The badges are made in batches, so a new member may experience a wait of a few weeks or months (depending on the production cycle). The accumulated badges are then brought to club meetings for distribution. *You must attend a meeting to get your badge!* It's not much of an inducement, but besides, you will find the meetings informative, fun and a helpful exchange between you and the other members. Mailing badges is cost prohibitive, so now you know how to get yours.

If you change your call sign, or otherwise have a change for your badge, tell the Keeper of the Database, WA1IDA, and a new badge will be ordered.

## **Need The History Of Your License?**

Those electing to contact FCC archives contractor, ITS Inc., to document having held an amateur license in the past are advised to telephone ITS instead of e-mailing. For a fee, ITS will research prior licensing records and should be able to provide you with the necessary documentary proof.

Call ITS at 717.337.1433 to place an order (e.g., for verification of a pre-March 21, 1987, amateur license). The verification letter you receive will be on FCC stationery and stamped with the FCC seal. The ITS Web site is **http://www.itsdocs.com**. Credit card orders are welcome.

## Notes for Running the BARC Net

First, check that the repeater is free. If there is a QSO going on, and it is a few minutes into the net, break in and gently remind them that it is net time. Remember that we can't force them to leave; most will QSY to let the net go ahead. If it is a few minutes into the net and there is still no net control, jump in and pick up the net.

Make sure you have a pen and a sheet of paper. The important thing to copy down is the call; it's nice to get the name and QTH, but that will come easier later on.

For logging, make three columns on the page, one for name and callsign, one for checkmarks for those with traffic, and one for notes. Leave a blank line between entries for additional notes.

This net doesn't have any logging requirements; the logs are for your use when running the net. Other nets may require a specific log to be sent to the net manager. If you have email access and you would like to, format the logs like n1ist's regular ones and send them to barc-list.

A question was raised about what equipment you need to run the net. If you use a HT, don't move around during the net (the signal flutters) and make sure you have a spare battery handy if it dies. For a mobile rig, you will usually have a hand mike. I mounted the mike hook on my radio rack; the side of a shelf next to your table works well. Be careful with desk mikes; it is too easy to drop some papers or a book on the PTT switch and lock up the repeater for an hour or so. If you have a boom mike with a foot switch, that would be a good choice.

## FCC says ULS registration can protect license record

Registering now on the FCC's Universal Licensing System can benefit amateurs, even if they have no plans to file an application anytime soon. FCC staffer Steve Linn, N4CAK, says that ULS registration "protects your call sign within the system" and could prevent it from inadvertently being deleted or reissued due to a filing error.

Linn also pointed out that amateurs filing for a change of address should file an "administrative update" (AU) and not request a "modification." The ULS will not renew an amateur's license unless it is within the 90-day window of expiration or within the two-year grace period after expiration. The same applies for those upgrading under restructuring.

Linn said the FCC continues to work out the bugs in the ULS. He said that support for the Mac platform and other browsers, such as Internet Explorer, should be available soon.

The FCC in late April opened the ULS to Web filing. Linn advised filers to use the on-line system whenever possible, since it helps users to avoid errors that will not get trapped when filing on paper and could lead to delays or errors in your FCC record. ## ARRL-VEC Picks Up Personnel, Processing Pace

The ARRL-VEC now has seven fulltime, three temporary, and eight just-added volunteer staff members chipping away at the mountain of applications resulting from the April 15 license restructuring. ARRL-VEC Manager Bart Jahnke, W9JJ, reports his staff now is wrapping up April 24 receipts from VE sessions. The ARRL-VEC received nearly 23,000 applications between April 15 and May 26.

ARRL-VEC staff was able to submit some 5000 applications to the FCC this week, up significantly from previous weeks. On May 25 alone, 1453 applications were filed with the FCC. Jahnke still estimates it will take approximately six weeks from exam session to the time the paperwork is filed electronically with the FCC, although some grants have been showing up sooner than that. The key is when the session paperwork arrived at ARRL-VEC. The FCC typically grants applications overnight.

Jahnke says there were approximately 4000 applications in the April 24 receipts alone that include sessions as long ago as March 25 and as recent as April 18. ARRL-VEC processes applications according to the date the package arrives in the mail. "We have

staff working over the weekend, and we will have staff working over the holiday weekend," he said.

Inquiries concerning the status of applications continue to impair the staff's ability to rapidly process the incoming stacks of applications. "You can't blame people for wanting to know what their status is, but when everyone wants to know, progress slows," Jahnke said. Another thing that slows progress is having to follow up on missing or incomplete information on the NCVEC Form 605 application from a test session.

Jahnke has estimated that the first 30 days of the restructuring surge--April 15 through May 15--will yield 17,200 new Generals and 13,100 new Extras. The ARRL-VEC is now posting the status of test session processing at

## Researcher Undertakes Study Of Radio Amateurs

National Cancer Institute researcher Kenneth Cantor has embarked on an epidemiological study of radio amateurs. Cantor wants to evaluate whether causes of death among amateurs differ from those of the general population. If it turns out that they do differ, he then wants to find out whether the individual's "usual occupation" might explain the differences.

Representatives of the ARRL RF Safety Committee met with Cantor at League Headquarters April 28 to discuss the project. On hand were Committee Chairman Greg Lapin, N9GL, Committee members Robert Gold, WB0KIZ, and Kai Siwiak, KE4PT, and David Sumner, K1ZZ, and Ed Hare, W1RFI, of the ARRL staff.

In addition to identifying ways that the League could assist in improving the study's accuracy, the meeting was aimed, in part, at educating committee members and League staff about the specifics of the proposed study.

Cantor described his investigation as an "inexpensive kind of quick study" that would not yield fine detail. As a result, he told the group, it would be "wrong" to ascribe the deaths to any particular factor.

The session presented an opportunity for Cantor to learn about influences amateurs tend to be exposed to in addition to RF energy. Cantor and the amateurs also were able to gain an appreciation for each other's points of view--Cantor on the public's sensitivity to the words used to explain the results of such an epidemiological study, and the amateurs on the significance of different types of epidemiological studies.

Some discussion at the session focused on a similar study done 15 years ago by Samuel Milham. Wording in that study's conclusions led many to believe that the Milham study had presented evidence that RF energy caused "an excess of leukemia."

Cantor emphasized that his investigation is a preliminary study, based on a statistical comparison of FCC licensing records and State of California death records. Additional death records might be included as needed. The initial "cohort group" for Cantor's study includes more than 100,000 men and women--seven times larger than the earlier Milham study.

"This type of study can be performed at minimal cost, but it has the potential for misleading results," said Lapin--himself a research

professional. Lapin explained that in the event of "apparent associations" in the results of Cantor's study, a follow-up study would be conducted. The followup would involve individual questionnaires and contact with the families of Silent Keys-something the Milham study did not attempt to do.


