### Field Day Satellite Station Call for Help

So this is a call for help for people who want to help get, setup and operate the station. ### TORNADOES IN SOUTHERN NEW ENGLAND

No, this is not the Midwest - and tornadoes do not strike Southern New England with the frequency that occurs out there. But they do happen often enough that we need to be aware of them and know what to do when they occur.

Here are some statistics for the 51-year period from 1950 to 2000. Worcester County, MA has had 34 tornadoes reported, which equates to roughly one every year and a half. But the last one on the list there was in 1990 - 11 years ago. In Middlesex County, MA there have been 17 tornadoes in the last 51 years - or about once every 3 years. But the last one on the list is back in 1986 - 15 years ago. Hartford County, CT gets 1 every 4 years on average, but the last reported tornado there was in 1994 - 7 years ago. The point is that we may be overdue.

The most frequent occurrences are in July and August. For Massachusetts, since 1950, here is the breakdown by month.

# SEVERE WEATHER DEFINITIONS, WATCHES AND WARNINGS

From National Weather Service

The National Weather Service defines a severe thunderstorm as one which produces large hail and/or damaging winds. Large hail is defined as being 3/4 inches (0.75 inches) in diameter - roughly the size of a dime or penny. Winds are considered severe if the thunderstorm producing them causes gusts to reach 58 mph or higher. At approximately these speeds, large tree limbs can break off and cause downed power lines. At higher speeds, whole trees can be uprooted.

A downburst is an exceptionally strong downdraft of air in a thunderstorm that spreads out violently at the ground - typically in a straight line path. Speeds as high as 175 mph have been recorded from a downburst. In May 1996, 104 mph was recorded in a downburst in the Brockton/Whitman/Abington area of Eastern MA causing 60 injuries. In May 1998, coincidentally, a gust to 104 mph also was recorded in Worcester MA. The downburst damage can be just as great as that of a tornado.

Severe thunderstorms can also spawn tornadoes. It takes a special set of atmospheric circumstances for this to happen. As a rule of thumb, however, any storm capable of producing golf ball size hail or larger has a well organized updraft and is capable of producing a tornado.

When atmospheric conditions are favorable for the development of severe thunderstorms, the storm prediction center in Norman OK will issue a severe thunderstorm watch. If a few of these could also produce tornadoes, a tornado watch will be issued. The watch often covers several states. It is your initial word that dangerous weather is possible.

If the National Weather Service issues a tornado warning, immediate action should be taken to protect life and property. A tornado warning means that a severe thunderstorm is in progress and that a tornado has either been sighted or is imminent, based on doppler radar imagery.

Unfortunately, some tornadoes can still develop so rapidly that a tornado warning may not be in effect. A severe thunderstorm warning may be in effect when a tornado strikes - such as in Great Barrington MA in 1995. Here in New England, tornadoes often are obscured in rainfall, making reports from SKYWARN weather spotters difficult at best.

Your first safety rule is that you must have a means of receiving the word that a watch or warning is in effect.

### **New CW Testing System at VE Exams**

The National Conference of Volunteer Examiner Coordinators voted to set up revised standards for the administration of Morse code examinations in the US. The move at the NCVEC's July 21, 2000 meeting in Gettysburg, Pennsylvania, came in the wake of the FCC's December 30, 1999, action to establish 5 WPM as the sole Amateur Radio Morse code requirement.

Under the NCVEC revised standards, examinees would have to show 25 character-count solid copy on their test sheets or successfully answer seven out of 10 questions of a fill-in-the-blank quiz on the sent text. Multiple-choice 10-question exams for Morse code are no longer permitted beginning July 1, 2001.

Morse examinations will specify use of the Farnsworth method of code generation as the default, where characters are sent faster than the overall speed and additional spaces added between characters, words and sentences. The Farnsworth "character speed" as a default must be within the range of 13 to 15 WPM. Standard 5 WPM tests with 5 WPM characters could be administered as a special accommodation (as the exception rather than the standard).

The revised standards also call for a Morse code exam audio pitch within the 700 to 1000 Hz range. The new Morse testing standards are to be in effect by next July 1, 2001.

Our exams already meet the speed and frequency as specified, but we will have to change from multiple-choice to fill-in-the-blanks starting with our July session.

- Valid ID (picture ID preferred)
- A pen and a calculator (if you want to)
- \$10.00 (good for all the tests you take at that session, except for retests).
- Note that code tests are no longer free. Those taking the code test only will also have to pay the \$10 fee. Code and written tests can be taken together at the same session for a single \$10 fee.

The needed FCC forms will be provided.


