2004 Ham of the Year – Blake Haskell, K1BTH -- Eric Falkof, K1NUN

Blake Haskell, K1BTH, was voted Ham of the Year for 2004 by members of the Boston Amateur Radio Club. Ballots submitted for Blake and others cited many accomplishments of individuals working together and individually for the benefit of Ham Radio and our club. In the end, we needed guidance to separate individuals but without weighting to an individual, for an event, or a narrow focus on a single activity. Consequently, the club elected the Ham of the Year according to the following general principles, which are suggested as a baseline for future awards:

The BARC Ham of the Year should possess most of the following qualities:

- Desire to promote the Boston Amateur Radio Club in positive ways to the community and other hams.
- Successes in promoting the BARC in a positive way, or successes at making legitimate attempts to promote BARC.
- Demonstrated ability to use ham radio for the furtherance of the communications arts.
- Demonstrated ability to organize Club members for mutual gain through the Club's participation.
- Demonstrated leadership in mentoring, instructing, or teaching ham radio-related skills or arts.
- Participation in club activities or events, at meetings or elsewhere.
- Supportive of BARC activities.
- Recognized by others (that is, sought out) as a leader or knowledgeable person for his or her skills and abilities.

The ham's class of license is immaterial, but the ham is required to be a BARC member and licensed by the FCC or the governmental authority of the ham's home nation.

In selecting Blake, we recognize his leadership in the club as Vice President for programming, his active participation in public service events, and his leadership in furthering the Club's visibility and role in public safety in the Boston area.

BARC members will do well to emulate Blake's attributes. Congratulations, Blake Haskell, K1BTH, 2004 Ham of the Year!

BARC VE Sessions

NOTE: The ARRL Volunteer Examination Coordinator (VEC) has announced that the exam fee for 2005 will be \$14.

The Boston Amateur Radio Club holds its monthly VE session on the second Monday of each month. Sessions are held at 7:00 pm at the Pierce School, 50 School St in Brookline, Room 110, next to the cafeteria. Future exam dates are listed below. A map is shown on page 7 of this newsletter.

If the Brookline public schools (or the Pierce School itself) is closed due to inclement weather or other problems, the exam session for that month will be cancelled. Otherwise, the exams will be on the second Monday of each month.

There is a free parking garage at the circular driveway. If driving, enter School Street from the Washington St side (opposite 394 Washington), rather than from Harvard St. Check: **www.barc.org/barc/school_map.gif** : for more info. This map also appears on page 7 of this newsletter.

For those traveling via public transportation, take the "D" branch of the **T** Green Line to the Brookline Village station. Walk north along Harvard St 0.2 miles to School St, then turn left. The Pierce School is on the left. The #66 bus runs on Harvard St, crossing School St.

Talk in on 145.230 MHz (-), PL 88.5 Hz.

We give all exams (Technician thru Extra, CW and written). You don't need to pre-register. Please bring the following with you:

- Your current license *and a photocopy for the ARRL*, if you are upgrading
- Any CSCEs you are claiming, and a photocopy of them
- Valid ID (picture ID preferred)
- A pen and a calculator (if you want to)
- **\$14.00** (good for all the tests you take at that session, except for retests)
- Note that code tests are no longer free. Those taking the code test only will also have to pay the \$12 fee. Code and written tests can be taken together at the same session for the same \$14 fee.

The needed FCC forms will be provided.

If Brookline schools are closed, the VE exams will be canceled. FCC Releases Hundreds Of Pages Of BPL Test Data, Filings

The FCC has made public more than 650 pages of technical presentations, correspondence and filings that it says it used in making its decision on the BPL Report and Order in ET Docket 04-37. The Commission adopted new rules to govern so-called Access Broadband over Power Line systems on October 14, but they have not yet become effective. The ARRL subsequently filed a Freedom of Information Act (FOIA) request that called on the FCC to release any studies the Commission had relied upon in deciding to embrace the technology. Some information contained in the documents has been blanked out or redacted.

"Certain portions of those presentations have been redacted, as they represent preliminary or partial results or staff opinions that were part of the deliberative process," FCC Office of Engineering and Technology Associate Chief Bruce Romano said in a cover letter releasing the documentation December 22. "Moreover, the redacted information was not relied on by the Commission in making its decision," Among the FCC Laboratory presentation charts the FCC redacted was one titled "New Information Arguing for Caution on HF BPL."

The documentation includes presentations and graphs resulting from field tests of BPL trials in PA, MD, NY and NC. The tests, conducted by the FCC Laboratory's Technical Research Branch, looked at BPL technology by Amperion, Current Technologies, Ambient Technologies and Main.Net.

The ARRL is continuing to review the extensive documentation in detail. ARRL Laboratory Manager Ed Hare, W1RFI, maintains that the FCC documents tend to back up assertions the League made in its filings. "The FCC reports clearly show that BPL operating at the FCC Part 15 emission limits generates a strong RF signal for long distances along overhead power lines," Hare said. "The FCC data showed noise that was many decibels above otherwise quiet ambient noise levels." Hare said that even in spectrum notched out by BPL system providers, the FCCprovided reports indicate a measurable increase in noise levels on amateur frequencies.

Approximately 150 pages of the documentation consisted of technical material and presentations by FCC staffers. The remaining 500-plus pages include correspondence, technical reports and interference complaints from radio amateurs to the FCC. Falling into the last category is extensive correspondence involving the Alliant Energy BPL field trial in Cedar Rapids, IA. That pilot project was abandoned after difficulties in resolving interference issues with local radio amateurs proved insurmountable.

The FCC just this week provided additional spreadsheet data to ARRL under separate cover. By releasing the information, the FCC made it part of the official record in the proceeding. Some, but not all, of the BPL-related material is on the FCC Electronic Comment Filing System under ET Docket 04-37.

In an interview January 3, OET Deputy Chief Bruce Franca asserted there's enough spectrum to permit Amateur Radio and BPL to coexist. Franca, who heads the Commission's BPL Task Force, spoke with Broadband over Power Line World's Marc Strassman.

"There are enough frequencies that amateurs can operate and BPL can operate in a compatible mode," Franca told Strassman. Franca also expressed confidence in technological solutions to any Amateur Radio - BPL interference issues that might arise. "I'm very optimistic at the end of the day," he said. "Technology is going to solve this problem."

ARRL Returns to Commissions for Clubs

Responding to the wishes of many ARRL-affiliated clubs, the League has reinstated the Club Commission Membership Recruitment Program. We continue to earn a \$15 commission for each new or lapsed (over two years) ARRL membership sent in. This program applies to both regular and senior ARRL membership dues. Excluded are family and blind memberships, and the program may not be combined with any other special offer or discount program.


