

Summer Fun in the Sun

Summer is a strange season, if you consider ham radio. Many of us take the summer off so we can spend time with our families or travel to exotic places while avoiding the trouble of boots, parkas, and gloves. Sometimes, we bring radios with us, but in deference to our travel-mates, we typically never turn the radios on. However, summer allows a special type of radio operation, often when those other travelers are asleep. First, let's consider the stay-at-homes, for whom this little article may be better suited. I'm talking about VHF and UHF propagation via a meteorological effect – temperature inversion.

What is an inversion? Simply, it is a reversal of the normal state of affairs when the earth is warm and it gets colder as you rise in altitude. Therefore, there is a layer of warm air over a layer of cooler air. That layer, either rising from below or descending from above, makes a denser layer for VHF and UHF signals to bounce off. Sometimes it can form a "sandwich" layer, or duct, and transport a radio signal many, many miles. Temperature inversions occur most noticeably early in the day (when our travel companions are asleep!) around dawn plus an hour or so. This is the time to break out our radios, open the squelch, and listen for those distant stations coming in over our repeaters or on direct frequencies. (Note: direct frequencies on the 2m band are channelized between 146.43 and 146.58 MHz.)

This is also the time to try other modes on your multiband, multimode radios, too! If you still believe in free TV, disconnect your roof-mounted TV from its beam antenna (not a satellite dish, but the one which is probably a form of log periodic that covers from just above the six meter band and goes up through the two meter band), crank the power *down* to a watt or two, connect one of those mini-balun gadgets between your radio (50 Ω side to the radio) and antenna, aim towards a population center, and listen carefully for the steady, pulsing, or fluttery signals from afar.

Now, for travelers and vacationers, take your HT during those morning hours and listen in, too. Your advantage may be that you travel to mountainous areas (where you might find yourself in such a layer of cool air sandwiched between two warmer layers that can act like a duct to transport your signal) or to the shore (where ducts frequently occur as warm air rises from the water, also to guide your signal up and down the coast).

But you won't ever be aware of these special conditions unless you put out a call! You gotta push that button or press that key. Remember: *Ham radio is a contact sport!*

Directions: The address is 19 Fort Hill St in Hingham. Coming from Boston on Route 3A South, cross over the Hingham/Weymouth Bridge, then take a right on to Beal St. At the end of Beal St, take a right on to West St. At the end of West St, at the Stop sign, take a right on to Fort Hill St. The immediate left will then bring you in to Bare Cove Park and the Fire Museum. There is a sign on the street for Bare Cove Park directing you into the Fire Museum and the South Shore Model Rail Road Club.

The entrance to Bare Cove Park is on South St, across from the South Shore Country Club, between the Hingham Credit Union and Thomas Auto Body (on Fort Hill St). Fort Hill St starts at the East Weymouth town line, but the name changes when it crosses the railroad tracks and it becomes South St.

The Boston Triathlon (formerly known as the Monster Challenge), which was run for the fourth time last year, continues to be an international success. We have been asked again this year to coordinate emergency and safety communications support.

Anywhere in the world a triathlon is an exciting and very demanding race. In urban Boston it is a further test of strength and determination. Designed to professional standards, the swimbike-run will be held on **Sunday, 4 September**. The Olympic-class triathletes will swim one mile, bike 25 miles, and run 6.2 miles. The course is laid out in Boston harbor, downtown Boston and Cambridge, and in the Boston seaport area. We have been specifically asked to monitor a number of hazardous and confusing locations for the safety of the participants as well as the medical stations.

As you read this, time is short – and your help is vital. A problem is that this is Labor Day weekend, so extra effort must go into getting enough hams. A bit of relief is provided by the schedule which expects the ham participation to go from **0600 to 1100** (some assignments close earlier), so the rest of your day is free. Here's a ham public service event where the reward might be better than the job. WGBH, the public TV channels 2 and 44, and FM radio, will hold their annual Ice Cream FunFest on **Saturday, 17 September,** at and around the WGBH station on Western Avenue in Brighton.

About 8000 to 10000 visitors are expected, all loaded into the one day. We have been asked to provide communications for the safety and management of the crowd and their vehicles. We plan a revised strategy for parking lot coverage so we can be more effective and efficient. It's a compact area, so 2-meter simplex HTs can be used.

A great advantage for us is that BARC is given free booth space for us to promote public awareness of ham radio to the visitors and staff. In past years our booth has introduced many people to our hobby and also stirred interest in several inactive hams. About 16 to 18 hams will be needed for communications and/or meeting the public.

Although such a good cause (and good publicity for us) doesn't need it, here's the good part: all volunteers get to eat all the ice cream you can consume (urp!). The ice cream is provided by a dozen manufacturers, so you can make comparative tests (urp, urp!)

KB1EKN Appointed Hingham Fire Chief

Boston Amateur Radio Club member and former President Mark Duff, KB1EKN, was sworn in as Fire Chief for the Town of Hingham on June 23, 2005. Mark had served as acting chief prior to the appointment. He was one of six finalists chosen from among 16 candidates for the position.

"This is a truly wonderful day for me and the Town of Hingham," said Mark, quoted in an article appearing in the *Hingham Journal*. "There were six wonderful, qualified candidates. But thanks for choosing me and having confidence in me. I also appreciate all the support from residents and my staff."

KB1EKN has more than 30 years of professional fire fighting experience with the Hingham Fire Department, both at the administrative and operational levels.

One of Mark's most graphic memories is when he and other ARES members from Eastern Massachusetts traveled to New York in the wake of the Sept. 11 tragedy to provide the American Red Cross with communications support.

As Deputy Fire Chief, Mark was in charge of overall department operations, including long-term planning, daily operations, and directing a staff of 50 firefighters and officers. He also supervised the handling of fires, hazardous materials incidents, search and rescue operations, and medical assistance. KB1EKN also developed Hingham's first Community Emergency Response Team (CERT).

Mark has also served as Hingham's Director of Emergency Management since 1996, developing action plans for the town in the event of natural disasters, terrorist threats, and other emergencies. He also managed the community's response to emergency situations, including hurricanes, snowstorms, and other major events. As training director, he planned and developed fire-service training programs.

In addition to his professional responsibilities, Mark has served as an ARRL District Emergency Coordinator for Metro Boston and recently, ARRL Assistant Section Manager for Eastern Massachusetts.

Public safety is a priority in this community, Mark told the *Hingham Journal*, "because the town makes it one. It will be wonderful to be Chief in a community where fire safety is taken so seriously. You will not be disappointed." [*Hingham Journal* story, June 23, 2005]

FCC Issues Revised Form 605, Obsoletes Previous Editions

A revised FCC Form 605, "Quick-Form Application for Authorization in the Ship, Aircraft, Amateur, Restricted and Commercial Operator, and General Mobile Radio Services," has gone into effect. The new form must be used for all receipts as of July 18.

"Applicants can avoid filing outdated editions by submitting their applications through the Universal Licensing System (ULS): http://wireless.fcc.gov/uls/, given that changes to the paper forms will be incorporated into the system automatically," the FCC said. The new Form 605 is available online from the FCC Web site: http://www.fcc.gov/forms/form605/605.html.

The revised form includes a new Question 13 (subsequent questions have been appropriately renumbered) that will affect amateurs applying for an administrative update (AU) to reflect a change in licensee name. Question 13 now asks: "If the licensee name is being updated, is the update a result from the sale (or transfer of control) of the license(s) to another party and for which proper Commission approval has not been received or proper notification not provided?" *Amateur Radio Service applicants should always answer* "no" to Question 13.

Not answering the question - which has nothing to do with the Amateur Radio Service - could result in dismissal of an application.

EMA Section News Summary (Extract) (19 July)

You can assist people in difficulty while traveling! EMA ARES recommends that you program your receivers and scanners to monitor the following emergency frequencies while traveling and vacationing out of our section. This follows recommendation as requested by REACT, and the US Coast Guard Auxiliary, for both of which the ARRL has a Memorandum of Understanding.

Amateur frequencies (Wilderness Protocol) [all FM simplex]: 146.52 MHz (2 meters) [Primary]

52.525 MHz (6 meters)

446.00 MHz (75 centimeters)

Remember to listen only for the first 5 minutes at the beginning of each hour.

Other frequencies to monitor:

>> Marine Band: Ch-16 (156.8 MHz FM)

>> International Calling and Distress, Citizen's Band (CB): Ch-9 (27.065 MHz AM)

>> National Emergency Channel monitored by REACT: FRS: Ch-1 (462.5625 MHz FM)

Simplex: 147.42

>> National Calling Channel advocated by F-R-S.org, and General Mobile Radio Service (GMRS): 462.675 MHz FM

CW or No CW?

Where do you stand? The FCC recently proposed eliminating CW as a requirement for ham radio licensing. (Refer to recent ARRL web pages for details and discussion.) The FCC cites many proposals, for and against, and culled them to its own. What do you think?

Traditionalists want to maintain CW as a filter to keep the riff-raff out, to "make men out of radio operators," or to ensure a level of skill in this emergency-focused mode.

Nouveau ops say a test should be related to the skills used, and CW is not the predominant mode. Therefore, eliminate it as a requirement. They say it is nonsensical to require a CW test to operate on voice or data modes. CW is also passé; even the military eliminated it.

Radio hams take both sides, and both sides are right. There is a level of skill required by those who choose to use it. Maybe make CW a requirement for those who want to use it. An endorsement, perhaps? But why restrict learners? Even voice users can key a mike's PTT switch.

CW exists. That's a fact. Now that CW is reduced (in speed) as a requirement, CW usage is growing. Would CW overtake SSB if we were prohibited from using CW? Imagine: clandestine groups meeting in basements to practice CW and then acting as pirates on the air, with false call signs and names... Get the picture? Like Tom Sawyer telling the kids they weren't qualified to whitewash A'nt Polly's fence, and thereby enticing them to show they really could do it... and Tom got away with no work while farming out the job to the rest.

Well, I don't think that will work, but there might be something to encouraging CW officially - perhaps by a band segment dedicated to those who passed a proficiency test. Some comments to the FCC proposal say CW should be maintained for Amateur Extras, so why not allow the bottom 25 kHz for CW only, and thereby requiring a CW endorsement (whether by license *or* special endorsement)?

Now, the ARRL has its own band plan based on mode bandwidth, and that's a whole other discussion. But I'm looking now just at CW: CW or no CW.

Every ham has an opinion. What's yours? Reply through the BARC-list and keep the discussion rolling.

The minutes of the July 2005 Business meeting were accepted as published in *The SPARC*.

Committee reports:

<u>Exams</u>: There are no exams currently scheduled until September 12, 2005 because of construction at the school. An alternate date will be scheduled in October due to Monday holidays.

<u>Membership</u>: Arthur reports no recent inquiries. Some former members have renewed as a result of phone calls that were made.

<u>Public Service</u>: The next event will be the Boston Triathlon on September 4, 2005. The WGBH Ice Cream FunFest will be on September 10; the Boston Bike Festival on September 25; and the BAA Half Marathon on October 19.

The SPARC folding will be on Wednesday, August 10 at the CambridgeSide Galleria at about 1830 in the Food Court lower level

<u>Programs and Activities</u>: Blake reports that we still are looking for a speaker for the September General meeting.

<u>Repeater</u>: Mike reports that the new controller works fine and there may be some modifications to allow the repeater to make preprogrammed announcements on the nth day of each month as reminders.

<u>Treasurer</u>: Jim reports a balance of \$3195.88 with an additional income of \$92 to be deposited.

The BARC Outing and Cookout will be held on Sunday, August 28 at the Bare Cove Fire Museum in Hingham, from 1300 to 1700.

BARC VE Session

VE Exams for August have been cancelled due to renovation of the Pierce School.

The Boston Amateur Radio Club usually holds its monthly VE sessions on the second Monday of each month. Sessions are held at 7:00 pm at the Pierce School, 50 School St in Brookline, Room 110, next to the cafeteria. Future exam dates are listed below. A map is shown on page 7 of this newsletter.

If the Brookline public schools (or the Pierce School itself) is closed due to inclement weather or other problems, the exam session for that month will be cancelled. Otherwise, the exams will be on the second Monday of each month.

There is a free parking garage at the circular driveway. If driving, enter School Street from the Washington St side (opposite 394 Washington), rather than from Harvard St. Check: www.barc.org/barc/school_map.gif: for more info.

We give all exams (Technician thru Extra, CW and written). You don't need to pre-register. Please bring the following with you:

- Your current license *and a photocopy for the ARRL*, if you are upgrading
- Any CSCEs you are claiming, and a photocopy of them
- Valid ID (picture ID preferred)
- A pen and a calculator (if you want to)
- \$14.00 (good for all the tests you take at that session, except for retests)
- Note that code tests are no longer free. Those taking the code test only will also have to pay the \$14 fee. Code and written tests can be taken together at the same session for the same \$14 fee.

The needed FCC forms will be provided.

Hams Are Needed for the Big E Exhibit


