#### **Equipment Familiarization at BARC Meeting**

The BARC General Meeting for October will be devoted to familiarization with BARC radio equipment. We will have two Yaesu 897 transceivers on hand for members to become familiar with. If we are called upon to staff a shelter, EOC, or command post, members should be able to set up one of these stations and get on the air in a timely fashion.

Joe Harris, KB1IXK, has become very familiar with the operation of this equipment and he will share his knowledge. We will break down into smaller groups for hands-on practice. At the end of the meeting, you will be able to take the equipment out of the box, attach an antenna and contact either of the BARC repeaters. We may also try some HF work, but I'm not sure if we will have set up time for the antennas. I plan to do this exercise occasionally with all of the Club equipment so every member can get some hands-on training.

Our General meetings are held on the third Thursday of each month at the Salvation Army Headquarters, 147 Columbus Ave, at the corner of Berkeley St in the third floor auditorium.

Our meetings are convenient to public transportation. The nearest **T** stations are Back Bay on the Orange and Purple lines (exit at the rear of the station and walk down Columbus), and Copley or Arlington (use the Berkeley St exit) stations on the Green line.

Free parking is available in the lot adjacent to the Salvation Army building. The entrance to the lot is from Columbus Ave (across the street from the firehouse). A map appears on page 7.

Talk-in is available on 145.230 MHz (-), CTCSS 88.5 Hz. If you arrive after 7:15 pm, ring the bell at the door to be admitted, as the door is locked at that time.

### **Amateur Radio SKYWARN Recognition Day**

On Saturday, 3 December 2005, SKYWARN Recognition Day will be held for the seventh straight year. SKYWARN Recognition Day is an event where National Weather Service Forecast Offices get on the air and make contacts with other NWS Offices as well as all Amateurs and any Amateur Radio SKYWARN Spotters. The purpose is to thank the thousands of Amateur Radio SKYWARN Spotters whose timely severe weather reports into NWS Forecast Offices across the country protect life and property.

In addition, NWS meteorologists, some of who are hams and some of whom are non-hams will be asked to get on the air and participate - if they are willing and quiet weather conditions enable their participation. The time period is Saturday, 3 December from 0000 to 2400 UTC. This equates to Friday, 2 December at 1900 EST through Saturday, 3 December at 1900 EST.

The National Weather Service in Taunton, MA uses call sign WX1BOX, and we look forward to our fourth year of participation. Of course, as many people recall in 2003, we had the infamous SKYWARN Recognition Day major snowstorm which dumped 1-2 feet of snow. Some locations got up to 3 feet, with damage caused by winds gusting over 60 MPH, and two cycles of moderate coastal flooding. Hopefully, the weather will be quiet to allow full participation in the event versus a long duration SKYWARN Activation for the time frame of the event. ## Activism and Ham Radio: Restrictive Covenants

Many years ago, I wrote my congressman to request a personal meeting to discuss ham radio and something else. My memory has dimmed so I disremember what it was about, but I had my five minutes during which I was admonished to provide more information to the Honorable One so he would have more knowledge of the subject. Well, I'm older and more tired, so I write letters.

The internet makes it much faster and easier... if he or she is willing to take the time to read email. Or would it be a staffer who reads it?

As I approach a new stage in life, I am thinking of a new home. One at which an antenna may not be allowed. (Dastardly thought!) So, a proposal in Congress piqued my interest enough that I wrote my congressman. You should write yours, too. Here's why:

Private housing developments and condominium complexes typically do not allow outside antennas; even small ones, like for

two meters. Never mind HF antennas, however compromised in size. If you live in such a situation or think you will ever be in one, now is the time to ask your representative to support House Bill 3876 which only asks for the same consideration in private housing developments as PRB-1 requires for public entities. Again, it does not require anything but consideration and accommodation *within reason*.

Here is the letter I wrote to my representative, the Honorable Martin Meehan. I sent an email, followed up with a hard copy. (I said in my email that a hard copy would come so it would not appear that I am flooding his inbox.) I specified the action I want him to take, why it is important to me, to him, and the nation. I identified an inconsistency in an FCC policy and its actions, and I offered more information if he needs it. Don't copy my letter, but you can use it as a basic form when you write yours.

It only takes a few minutes, but it may allow years of enjoyment of our favorite service and hobby, instead of going QRT.

Dear Representative Meehan,

Subject: HR 3876, Amateur Radio Emergency Communications Consistency Act

Please cosponsor HR 3876, "Amateur Radio Emergency Communications Consistency Act," sponsored by Rep. Steve Israel. This act affects many federally licensed Amateur Radio (Ham) operators living in development communities and who are subject to unreasonable restrictions or summary prohibitions regarding installation of external (outdoor) antennas.

Current FCC law instructs states and localities they must reasonably accommodate Amateur Radio antennas. However, this policy does not address situations affecting private land-use groups. Rep. Israel's bill would ensure *consistent application* of these same regulations.

#### Why this is important...

You see, the legislation seeks to ensure Amateur Radio operators are available for emergency communications in all sections of the country, regardless whether they live in a development (such as a townhouse subdivision) or retirement community. Restrictions against antennas, even modest and reasonable ones, prevent Amateurs from exercising their license operations and prevent them from fulfilling another FCC policy requiring Amateurs to prepare for providing emergency communications. Ultimately, this leaves Amateurs unable to prepare for potential communications roles during times of disaster or national crisis.

FCC policy requires preparation, but does not support such preparation. This bill helps remedy this inconsistency.

Remember, all recent disasters have cited lack of communications as a primary and significant problem. Amateur Radio provides a vital public safety communications service to the public at no cost to taxpayers. I hope you will join Rep. Israel in cosponsoring this bill.

I look forward to hearing from you as you consider this important legislation, and if you have any questions, please feel free to contact me.

#### Let The Seller Beware!

The ARRL again cautions anyone selling Amateur Radio and related equipment via Radios On-Line or *QST* Ham Ads (or via on-line auction sites or other advertising media) to beware of so-called "advance fee fraud" (or 4-1-9) payment schemes **www.secretservice.gov/alert419.shtml** aimed at ripping you off. We continue to receive reports from ARRL members who have received responses to their ads from individuals offering to overpay for goods via bank check with instructions to deduct the cost of their item(s) from the overpayment (typically quite substantial) and return the "change" to the buyer or another individual. The "bank check" is bogus, however, and the seller ends up holding the bag. This is a well-known scam. There's additional information on the Scam Victims United Web site, www.scamvictimsunited.com/. Remember: Transact carefully, and protect yourself from fraud!

# **FEMA Courses On Amateur Radio Resources; ICS / NIMS Training**

Here is a solution to help public officials learn to interface with Amateur Radio assets: government-approved Federal Emergency Management Agency (FEMA) training course "G250.6 - Workshop: Amateur Radio Resources." This three- to four-hour workshop is designed to provide state and local elected officials, emergency managers, and other public officials with an understanding of how Amateur Radio volunteer communication groups can help in supplementing telecommunication and warning systems. Please direct them to the FEMA Emergency Management Institute (EMI) at www.training.fema.gov/emiweb/ to register for this course.

The unavailability of local FEMA Incident Command System /National Incident Management System (ICS/NIMS) seminars should not deter anyone from undertaking these important training topics (IS-100, IS-200 and IS-700, as well as other emergency management courses), as they are available on-line. See <a href="https://www.training.fema.gov/emiweb/is/crslist.asp">www.training.fema.gov/emiweb/is/crslist.asp</a>. A completion certificate is issued by FEMA for the on-line courses.

- Your current license *and a photocopy for the ARRL*, if you are upgrading
- Any CSCEs you are claiming, and a photocopy of them
- Valid ID (picture ID preferred)
- A pen and a calculator (if you want to)
- \$14.00 (good for all the tests you take at that session, except for retests)
- Note that code tests are no longer free. Those taking the code test only will also have to pay the \$14 fee. Code and written tests can be taken together at the same session for the same \$14 fee.

The needed FCC forms will be provided.


