#### Field Day - With Air Conditioning!

Our 2006 Field Day will be conducted from the Emergency Operations Center (EOC) at the Salvation Army Headquarters in downtown Boston. This is the same location that BARC holds it's monthly meetings. We will be operating under ARRL, Field Day rules as a "Class F" station. The date is Saturday, June 24. The present plan is for one HF phone station and limited VHF. The schedule is to be on the air from 1400 to 1900, local time. Orientation to the equipment will begin at 1200.

Free parking is available in the lot next to the building. It may be necessary for participants to call in on 145.230 to have the gate opened.

This is a great opportunity to become familiar with the facility and it's equipment. The Salvation Army is one of BARC's primary served agencies. We played a key role in the passing of health and welfare traffic in the aftermath of Hurricane Katrina. It is important that we continue to support the Army and the SATERN (Salvation Army Team Emergency Network) program.

Those interested in participating are welcome to stop by at any time during the event. This will be the first time we have done Field Day in this venue, and plans are still in the development stage - so stayed tuned.

#### **Bikes Not Bombs Needs Us Again**

After years of sponsoring a Bike-A-Thon to benefit youth bicycle programs, the Bikes Not Bombs organization of Boston realized the value of reliable communications. BARC has been asked to assist this event for the past two years and again this year. The date is **Sunday, 11 June**.

There are three concurrent courses - 15 mile, 25 mile, and 62 mile, each with separate rest stops and support vehicles. 185 riders are expected, and we are tasked with monitoring the rest stops, follow vehicles and a few shadows. All rides start near Jamaica Pond. There will be no assignments on the streets.

We assemble at 0800 at a restaurant parking lot in Roxbury Crossing. Cars can be left there as the lot is secure. Transportation will be provided to the outlying rest stops, but you may proceed directly if you wish. The shorter courses should be finished by 1400 and the longer course should finish by 1630. All finishes are at Mississippi's Restaurant where a gourmet dinner buffet will be provided. Note that our gourmand food testers have declared this feed to be superb.

#### NIMS/ICS Training Essential

-- ARES E-Letter, February 15, 2006

The Department of Homeland Security is requiring all first responders, including volunteers, to complete at least introductory training in the National Incident Management System (NIMS) by 2007. This sounds formidable, but in reality there is an Independent Study course from FEMA that covers it. The course is IS-700. Go to www.training.fema.gov/emiweb/is/crslist.asp and find the course list. Follow directions and you will get to IS-700. Readers can take the course on line or download the material and do it at their own pace. It shouldn't take more than three hours in any case. There's a final exam on line, but it isn't going to cost much sweat (or any money - courses are all free). After passing the final, the student will get notification by e-mail or regular mail.

Readers are encouraged to look at the rest of the course offerings on the FEMA training Web site. They represent a wealth of knowledge, organized so that us real people can get through them and actually learn something. They aren't rocket science, just good stuff we need to know! #### **Technician Class Question Pool Revised**

-- ARRL Letter, 27 January 2006, 24 February 2006

The National Conference of Volunteer Examiner Coordinators (NCVEC) Question Pool Committee (QPC) has released the revised Technician (Element 2) question pool. The new Element 2 pool is available for viewing or download in Adobe .pdf, MS Word, RTF and ASCII text format from the NCVEC Web site: www.ncvec.org/ama\_news\_article.php?id=82.

The new question pool becomes effective for all examinations administered on or after July 1, 2006, and it will remain valid until June 30, 2010.

The new Technician pool contains 396 questions, from which 35 are selected for an Element 2 examination. This question pool contains no graphics or diagrams.

#### In Support of "Plain Language"

-- FEMA NIMS FAQ from ARES E-Letter, February 15, 2006

The use of plain language in emergency response situations is a matter of public safety, especially the safety of first responders and those affected by the incident. All local responders, as well as those coming into the impacted area from other jurisdiction must know and use commonly established operational structures, terminology, policies and procedures. NIMS and the Incident Command System (ICS) are about achieving interoperability across jurisdictions and disciplines.

The use of common terminology is about the ability of commanders, EOC personnel, coordinators, and responders to communicate clearly and to coordinate response activities. FEMA requires that plain English be used for multi-agency, multi-jurisdiction and multi-discipline events, such as major disasters and exercises. Beginning in October 2007, funding is contingent on the use of plain English in major incidents. It is important to practice everyday terminology and procedures that will need to be used in emergency incidents and disasters. Implementation is a long-term effort and it's probably not possible to persuade everyone to change. But over time, everyone will understand the importance of using common terminology, that is, plain English, every day. See:



# Low Voltage Measurement: Receiver Sensitivity – A Semitechnical Article

Do you remember the good ol' days when receiver sensitivity was measured in microvolts? Are you confused about dbm measurements and how numbers with greater absolute value (remember junior high math?) represent ever decreasing sensitivities? And what about signal generator output so you don't blow out your receiver front end?

Well, here's a handy chart for conversion of dbm and microvolts. This is even less complicated than last month's nomogram! Use the chart for comparisons of your favorite radio's ears or for understanding the ARRL's equipment reviews.

For those traveling via public transportation, take the "D" branch of the T Green Line to the Brookline Village station. Walk north along Harvard St 0.2 miles to School St, then turn left. The Pierce School is on the left. The #66 bus runs on Harvard St, crossing School St.

We give all exams (Technician thru Extra, CW and written). You don't need to pre-register. Please bring the following with you:

- Your current license *and a photocopy for the ARRL*, if you are upgrading
- Any CSCEs you are claiming, and a photocopy of them
- Valid ID (picture ID preferred)
- A pen and a calculator (if you want to)
- \$14.00 (good for all the tests you take at that session, except for retests)
- Note that code tests are no longer free. Those taking the code test only will also have to pay the \$14 fee. Code and written tests can be taken together at the same session for the same \$14 fee.

The needed FCC forms will be provided.


