The NEQP is a great time to check out antenna systems and offers a moderately paced opportunity to work new states and countries. You'll find a wide variety of participants, from newcomers to experienced contesters, all interested in making contacts with New England stations.

We're working to make sure that all of the New England counties are active again this year and would appreciate your help. Get on for at least an hour or two and join in on the fun. Please let me know if you can put in any time at all so we can work on activity from the rarest counties. Will you be QRV? Let us know which county you'll be on from with a message to info@neqp.org.

Oh yes, the NEQP is also **lots** of fun when mobile. Every time you cross a county line the action starts over again. It's amazing what a 100w radio and mobile whip can do.

The QSO Party is 20 hours long overall, in two sections with a civilized break for sleep Saturday night It goes from 4pm Saturday until 1am Sunday, then 9am Sunday until 8pm Sunday. Operate on CW, SSB and digital modes on 80-40-20-15-10 meters. For each QSO you'll give your callsign, a signal report and your county/state. Top scorers can earn a plaque and everyone who makes 25 QSOs and sends in a log will get a certificate.



Hamming in the Age of COVID - Doc Kinne, KE1ML, ORS

We're certainly in a different age than we were in when I last wrote you. We can hope that this age doesn't last too long, but it has already greatly affected us, not least our hamming.

There are, of course, the bad things that the COVID-19 pandemic has done—canceling virtually everything from our own meetings to the United State Amateur Radio Direction Finding Championships that were scheduled to be held near Boston in June. Dayton, of course, has been canceled. At this point Skywarn training for the year has also been canceled. The Eastern MA web page (http://ema.arrl.org) currently has a running feed on what the status is of meetings and events in our Section. If you're

planning on going anywhere, it is certainly worth a read, but *always*, at this point, check with the event itself to make sure of its status before you head out.

Virtually all DXpeditions have been canceled, largely due to the extended quarantine most countries have instituted for incoming travelers. It's difficult to activate a certain country or location if it's going to take an additional two weeks to get there, even if you can get there, now, in the first place.

Contests have been affected as well, both good and bad. Some of our contests are events where we get together, physically, and operate multi-op stations. These contests, or at least those parts of the contests, have been adversely affected. On the positive side, for those contests that have significant home activity, such as the ARRL Rookie Roundup, we may be able to look forward to come increased activity.



No matter what happens at this point, Field Day is going to be different. I'm not aware that Field Day has ever been *canceled*, outside of anytime when amateur radio itself has been knocked off the air. At this point the League has acknowledged that FD this year will be different and as amateurs we'll have to adapt. And that's not a bad thing. We figure that there will be an increase in home/emergency (Class E) stations, among other changes.

Non-amateur events near and dear to many of our hearts have also been either canceled or substantially delayed. The Boston Marathon, in this case, has been re-scheduled for September.

COVID has also disrupted component delivery and

pipelines. Icom, for example, has had to announce the delay of the upcoming IC-705.

However, there are some good things that this situation has brought about for us. When you get right down to it, Amateur Radio operators are the original social distancers. We were made for this! As a Traffic Handler, I've noticed perhaps a 40% uptick in check-ins to both the Eastern MA 2m Traffic Net as well as the MA/RI Phone Net.

New or expanded on-air nets are also taking place. Pilgrim AWA is active. Framingham ARA has started additional nets and frequencies as well as taking a look at ZOOM for their monthly meetings for the duration of the crisis. The President of the Radio Society of Great Britain has actually gone so far as to officially encourage hams to arrange skeds, both on-air and with video calls or simple phone calls, to make sure that our community keeps track of, and takes care of, our community.

New license exams have taken a nose dive, but they're not dead! The W5YI VEC has actually produced a Technician-class license late last month by a virtual testing session. Interestingly enough, virtual testing services have been legal since 2014 and have extensively used in AK, although there they have had virtual sessions with one proctor in the room. W5YI, now that the initial experiment is done, is looking to expand this. The League seems to be playing catch-up here. We're expecting that a good many people are using this period to study up for their next license—myself among them!—and that we'll end up seeing a surge in new license tests once COVID dies down.



In the end, while hams can have the reputation of being somewhat stodgy at times, really, we're very flexible. COVID is again proving that. I think we'll come out of this tunnel the better for it!
